Commissioner Neidinger reported on Public Works Department activities including storm cleanup after Hurricane Idalia, road repairs, the installation of holiday decorations and the closure of the tennis courts at Bay View Park for resurfacing.

Commissioner Thomas reported on Community Improvement Department activities including local business developments, business tax receipts, and plan review projects.

Commissioner Thompson reported on Finance Department activities including the annual budget process and reviewed City financials.

Vice Mayor Reid spoke regarding the remembrance of September $11^{\rm th}$ on behalf of the Public Safety Department.

In Mayor Penny's absence, Vice Mayor Reid spoke regarding Administration Department activities including public hearings for the adoption of a final millage rate and FY 2024 budget, the mural program, and the City's dolphin statue.

PUBLIC HEARING

1. RESOLUTION NO. 2023-08 - A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF SOUTH PASADENA, FLORIDA, ADOPTING A TENTATIVE MILLAGE RATE FOR AD VALOREM TAXES FOR THE CITY OF SOUTH PASADENA FOR FISCAL YEAR 2023-2024, PROVIDING FOR AN EFFECTIVE DATE.

City Attorney Mandell read Resolution No. 2023-08 by title and approved it as to form and content.

Vice Mayor Reid stated that the purpose of the public hearing is to receive input on the budget process from the public and the City Commission. He reported that this meeting will accomplish the following in accordance with State Statutes:

- a. Announce the proposed millage rate adopted by the City Commission on July 3, 2023.
- b. Receive comments and questions from the public on both the budget and the millage rate and answer the public's questions.
- c. Adopt a tentative millage rate.
- d. Adopt a tentative budget.

Finance Director Graham announced that a proposed tentative millage rate of 4.9650 was adopted on July 3, 2023, which is an 11.88% increase over the roll-back rate. He said that the roll-back rate is 4.4376 mills. He explained that the roll-back rate is the true millage rate necessary to collect the same total revenue as collected in the previous year on the same properties. He reported that taxable values increased \$109.9 million which will generate \$543,710 more in revenue than the previous year.

ORDINANCE NO. 2023-05 - AN ORDINANCE OF THE CITY OF SOUTH PASADENA, FLORIDA AMENDING THE CITY'S COMPREHENSIVE PLAN LAND USE ELEMENT, INFRASTRUCTURE - WATER SUPPLY ELEMENT, ELEMENT, CONSERVATION COASTAL MANAGEMENT RECREATION AND OPEN SPACE ELEMENT, INTERGOVERNMENTAL COORDINATION ELEMENT, AND CAPITAL IMPROVEMENTS ELEMENT, ADDING A PROPERTY RIGHTS ELEMENT, ELIMINATING EXHIBIT A -EXISTING LAND USE MAP, RENUMBERING AND UPDATING EXHIBIT B -COASTAL HIGH HAZARD AREA MAP, RENUMBERING AND UPDATING EXHIBIT C - FUTURE LAND USE MAP PURSUANT TO THE CITY OF SOUTH PASADENA EVALUATION AND APPRAISAL REVIEW (EAR) UNDER THE PROCEDURES ESTABLISHED IN SECTIONS 163.3184(2) AND (4), FLORIDA STATUTES; PROVIDING AUTHORITY; PROVIDING PURPOSE AND INTENT; PROVIDING FOR ADOPTION OF AMENDMENTS CERTAIN ELEMENTS OF THE COMPREHENSIVE PLAN; PROVIDING FOR SEVERABILITY; REPEALING ALL ORDINANCES IN CONFLICT; AND PROVIDING FOR AN EFFECTIVE DATE - FIRST READING.

City Attorney Mandell read Ordinance No. 2023-05 by title and approved it as to form and content. She announced that the City Commission, sitting as the Local Planning Agency (LPA), just concluded its public hearing to consider Ordinance No. 2023-05. She announced that after consideration of the item and public comment, the City Commission acting as the LPA has recommended approval.

City Mandell added that during the previous Special Commission Meeting, the Local Planning Agency voted to recommend the adoption of the changes for the City of South Pasadena Comprehensive Plan as recommended by Staff.

Vice Mayor Reid opened the public hearing at 7:37 p.m.

City Clerk Lewis questioned if she should read the written comments that were submitted for the previous hearing.

The consensus of the Commission was to accept the two subject written comments from the previous Special Commission Meeting into the record (attached to the Minutes as Exhibit A).
