PUBLIC HEARING - QUASI-JUDICIAL

1. CONSIDERATION OF APPLICATION FOR AN AMENDMENT TO PREVIOUSLY APPROVED SPECIAL EXCEPTION FROM CAUSEWAY VILLAGE MHC, LLC FOR 1375 PASADENA AVENUE SOUTH, SOUTH PASADENA, FL 33707.

Mayor Penny opened the public hearing at 8:17 p.m.

City Attorney Mandell asked the City Commission to disclose all ex-parte communications regarding the pending case

before the board. She informed the participants about the record of hearing process.

City Clerk Lewis administered the oath of testimony to those intending to give testimony.

City Attorney Mandell introduced the item. She stated that the City Commission, sitting as the Planning and Zoning Board, just concluded its public hearing to consider the application for an amendment to previously approved special exception from Causeway Village MHC, LLC for 1375 Pasadena Avenue South, South Pasadena, FL 33707. She announced that after consideration of the evidence and public comment, the City Commission acting as the Planning and Zoning Board has recommended denial of the application. She said that this hearing is for the City Commission to consider the recommendation and any further evidence or testimony to either approve or deny the application. She recommended that the City Commission accept all the evidence and testimony from the previous Special Commission Meeting into the record for the current meeting.

He stated that the requested amendments do not affect compatibility or the public interest.
