ADMINISTRATIVE WORKSHOP

TUESDAY, APRIL 16, 2024 SOUTH PASADENA, FLORIDA COMMISSION CHAMBERS - 9:00 A.M.

The first topic for discussion was Proposed Regulatory Changes Regarding Local Development.

Commissioner Thompson spoke regarding proposed regulatory changes previously discussed as part of the SunRunner Rising Development Study and distributed a handout (attached to Minutes as Exhibit A). She spoke in favor of pursuing the recommended changes along Gulfport Boulevard and suggested that grants may be available to assist in the process.

City Attorney Mandell suggested contacting Forward Pinellas to inquire about what services they may be able to provide if the City wishes to pursue the proposed changes.

Discussion ensued regarding local development.

City Clerk Lewis stated she would contact Forward Pinellas with regard to the Commission's interest in regulatory changes regarding local development.

The next topic scheduled for discussion was Public Works Vehicles Budgeted Expenditures.

Public Works Director Shimko spoke regarding his previous request to transfer funds within his budget to purchase a bucket truck.
