RESOLUTION NO.

A RESOLUTION OF THE CITY OF SOUTH PASADENA TO TEMPORARILY REDUCE BY FIFTY PERCENT (50%) BUILDING PERMIT FEES BEGINNING OCTOBER 1, 2024, THROUGH AND INCLUDING MARCH 31, 2025, FOR REPAIR AND DEMOLITION OF HURRICANE DAMAGED RESIDENTIAL AND COMMERCIAL STRUCTURES; INSTALLATION OF MATERIALS AND EQUIPMENT WITHIN AND ATTACHED TO DAMAGED STRUCTURES; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on September 26, 2024, storm surge and high winds from Hurricane Helene caused significant flood damage from storm surge to the ground floor of many residential and commercial properties throughout the City of South Pasadena; and

WHEREAS, on October 9, 2024, high winds and heavy rains from Hurricane Milton also caused significant damage to many structures; and

WHEREAS, damage from these two hurricanes is an extraordinary condition that warrants waiver of certain permit fees; and

WHEREAS, the City Commission of the City of South Pasadena maintains that hiring a licensed contractor and obtaining a building permit provides protection for property owners of the City; and

WHEREAS, the City Commission of the City of South Pasadena wishes to encourage property owners to hire licensed contractors and obtain building permits by proposing a partial temporary waiver of permit fees for repairs and demolition of hurricane-damaged residential and commercial structures, and for installation of replacement materials and equipment within and attached to damaged structures; and

WHEREAS, other permit fees associated with non-occupied structures, reinspection fees, surcharge fees, and fees associated with new construction, including new construction following demolition, are not to be waived; and

WHEREAS, numerous of our neighboring cities have temporarily waived permit fees relating to repairing damage caused by the recent hurricanes, including but not limited to unincorporated Pinellas County, St. Pete Beach, Treasure Island, Gulfport, Sunset Beach, Madeira Beach, Indian Rocks Beach, Belleair Shores, Belleair Bluffs, St. Petersburg, and Clearwater; and WHEREAS, the City Commission of the South Pasadena after due consideration, has determined that a temporary partial waiver of building permit fees from October 1, 2024, through March 31, 2025, is in the best interest of the City of South Pasadena.

Now, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION of THE CITY OF SOUTH PASADENA, THAT:

Section 1. Each of the above recitals is incorporated herein as the findings of the City Commission.

Section 2. There shall be a temporary waiver of Fifty Percent (50%) of certain City of South Pasadena building permit fees from October 1, 2024, through March 31, 2025, for permits applied for repairs or demolition of storm-damaged structures and for installation of materials and equipment within and attached to damaged structures resulting from the effects of Hurricanes Helene and Milton.

Section 3. Applicants who have applied for, paid for and received permits from October 1, 2024 and prior to enactment of this resolution shall be entitled to a refund equal to the 50% waiver consistent with this resolution, provided such applicants request a refund, in writing, and can demonstrate the permit was issued for storm damage related to Hurricanes Helene or Milton.

Section 4. This Resolution is effective immediately upon adoption,
