BACKGROUND:

The applicant, Krystal Zamora, Permitting Manager with Gulf Coast Marine Construction, on behalf of the property owner, Max V. Elson, Jr., requests approval of a Special Exception application **PNZ-0526-005** pursuant to Sections 130-17(C)(3) and 130-48 of the Land Development Regulations to replace ninety (90) linear feet of existing seawall, construct the replacement seawall utilizing vinyl sheet pilings extending up to twelve (12) inches waterward of the existing seawall face, and increase the finished top-of-seawall elevation from approximately 4.9 ft NAVD88 to 5.9 ft NAVD88, an increase of approximately twelve (12) inches, at the subject property located at 7140 South Shore Drive S, South Pasadena, Florida 33707. The subject property is located within the RS-70 Single-Family Residential Zoning District.

For reference, the existing top-of-seawall elevations are as follows:

Subject Property (Existing):	4.9 ft NAVD88
Subject Property (Proposed):	5.9 ft NAVD88
Adjacent Property (North):	4.8 ft NAVD88
Adjacent Property (South):	5.5 ft NAVD88



ANALYSIS:

The following is a review of the proposed Special Exception pursuant to Sections 130-17(C)(3) and 130-48 of the Land Development Regulations. The Background section of this Staff Report is hereby incorporated by reference into this analysis. Pursuant to Section 130-17(C)(3) of the City Code, seawalls require approval of a Special Exception; however, repairs to or the exact replacement of an existing seawall are exempt from this requirement. Because the proposed project includes construction of the replacement seawall utilizing vinyl sheet piling positioned up to twelve (12) inches waterward of the existing seawall face, in addition to an increase in the finished top-of-seawall elevation from approximately 4.9 ft NAVD88 to 5.9 ft NAVD88, the proposal does not constitute an exact replacement and therefore requires approval of a Special Exception by the City Commission.

Pursuant to Section 130-48(A) of the Land Development Regulations, the City Commission shall make findings on the following four (4) criteria:

Criterion 1 | "That granting the special exception will not adversely affect the public interest."

Staff Analysis:

The proposed replacement of approximately ninety (90) linear feet of existing seawall, including construction of the replacement seawall utilizing vinyl sheet pilings extending up to twelve (12) inches waterward of the existing seawall face, and the twelve (12) inch increase in the finished top-of-seawall elevation will improve shoreline stabilization and flood resilience while continuing to protect the subject property. Staff finds the proposed Special Exception will not adversely affect the public interest.

Finding: Consistent

Criterion 2 | "That the requested use is reasonably compatible with surrounding uses. In making this determination the following factors should be considered:"

Staff Analysis:

The proposed seawall replacement, including the minor waterward extension, will continue to serve the existing single-family residence within the RS-70 Single-Family Residential Zoning District. The proposed top-of-seawall elevation of 5.9 feet NAVD88 is generally compatible with existing seawall elevations on the immediately adjacent waterfront properties, which are approximately 4.8 feet NAVD88 to the north and 5.5 feet NAVD88 to the south. The factors listed in Section 130-48(A)(2)(a) through (d) are either not applicable or are unaffected by the proposed seawall replacement.

Finding: Consistent

Criterion 3 | "That the land and building area is adequate for the operation of the use."

Staff Analysis:

The proposed Special Exception is limited to the replacement of approximately ninety (90) linear feet of existing seawall, including the minor waterward extension and the increase in the finished top-of-seawall elevation. The subject property provides adequate area to accommodate the proposed improvement, and no change to the existing residential use is proposed.

Finding: Consistent

Criterion 4 | "That approval of the use will not result in reduced land values and detract from surrounding areas."

Staff Analysis:

Staff finds the proposed seawall replacement, including the minor waterward extension and increase in the finished top-of-seawall elevation, will improve shoreline protection while maintaining compatibility with adjacent waterfront properties and the surrounding residential neighborhood. Staff has identified no characteristics of the proposed seawall replacement that would reasonably be expected to reduce surrounding property values or detract from the surrounding area.

Finding: Consistent

STAFF RECOMMENDATION:

Based upon staff's review of the application and supporting documentation, and the Special Exception review criteria set forth in Section 130-48 of Chapter 130, Land Development Regulations, staff finds that the proposed request is consistent with all four (4) Special Exception criteria. Staff therefore recommends approval by the City Commission of Special Exception application **PNZ-0526-005** submitted by Krystal Zamora, Permitting Manager with Gulf Coast Marine Construction, on behalf of the property owner, Max V. Elson, Jr., pursuant to Section 130-48 of the City Code, to replace approximately ninety (90) linear feet of existing seawall, construct the replacement seawall utilizing vinyl sheet piling positioned up to twelve (12) inches waterward of the existing seawall face, and increase the finished top-of-seawall elevation from approximately 4.9 feet NAVD88 to 5.9 feet NAVD88, an increase of approximately twelve (12) inches, at the property located at 7140 South Shore Drive South, South Pasadena, Florida 33707, subject to the following conditions of approval, which Staff recommends the City Commission consider pursuant to Section 130-48(B) of the City Code:

Recommended Conditions of Approval

1. The proposed replacement seawall, including the approved alignment, shall be constructed substantially in accordance with the plans and supporting documents submitted with Special Exception Application **PNZ-0526-005**, except as may be modified by the City Commission.
2. The approved finished top-of-seawall elevation shall not exceed 5.9 feet NAVD88, referenced to the North American Vertical Datum of 1988 (NAVD88).
3. The replacement seawall utilizing vinyl sheet piling shall not extend more than twelve (12) inches waterward of the existing seawall face. Any extension beyond twelve (12) inches shall require additional City review and approval, as applicable, in addition to any required authorization from other regulatory agencies.
4. The applicant and owner shall obtain all applicable federal, state, county, and local permits and approvals prior to commencement of construction.
5. Any proposed change to the approved finished top-of-seawall elevation, approved seawall alignment, or other material revision to the approved Special Exception shall require review and approval by the City in accordance with the City Code.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF SOUTH PASADENA, FLORIDA, APPROVING SPECIAL EXCEPTION APPLICATION PNZ-0526-005 PURSUANT TO SECTIONS 130-17(C)(3) AND 130-48 OF THE CITY CODE TO REPLACE NINETY (90) LINEAR FEET OF EXISTING SEAWALL, CONSTRUCT THE REPLACEMENT SEAWALL UTILIZING VINYL SHEET PILING EXTENDING UP TO TWELVE (12) INCHES WATERWARD OF THE EXISTING SEAWALL FACE, AND INCREASE THE FINISHED TOP-OF-SEAWALL ELEVATION FROM 4.9 FEET NAVD88 TO 5.9 FEET NAVD88, AN INCREASE OF TWELVE (12) INCHES, AT THE PROPERTY LOCATED AT 7140 SOUTH SHORE DRIVE SOUTH, SOUTH PASADENA, FLORIDA; PROVIDING CONDITIONS OF APPROVAL; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Krystal Zamora, Permitting Manager with Gulf Coast Marine Construction ("Applicant"), on behalf of Max V. Elson, Jr. ("Property Owner"), submitted Special Exception Application No. PNZ-0526-005 requesting approval to replace approximately ninety (90) linear feet of existing seawall, construct the replacement seawall utilizing vinyl sheet piling extending up to twelve (12) inches waterward of the existing seawall face, and increase the finished top-of-seawall elevation from 4.9 feet NAVD88 to 5.9 feet NAVD88 at the property located at 7140 South Shore Drive South, South Pasadena, Florida; and

WHEREAS, the subject property is legally described as: Lot 61, Block 1, Pasadena Isle, according to the plat thereof, as recorded in Plat Book 47, Page 9, of the Public Records of Pinellas County, Florida; and

WHEREAS, pursuant to Sections 130-17(C)(3) and 130-48 of the City Code, seawalls require approval of a Special Exception, except that repairs to or the exact replacement of an existing seawall are exempt from this requirement, and the proposed waterward extension and increase in the finished top-of-seawall elevation do not constitute an exact replacement and therefore require approval of a Special Exception by the City Commission; and

WHEREAS, the City Commission conducted a duly noticed public hearing in accordance with the City Code and considered the application, Staff Report, supporting documents, and testimony presented by all interested parties; and

WHEREAS, after reviewing the competent substantial evidence presented, the City Commission finds that the requested Special

Exception satisfies the review criteria set forth in Section 130-48(A) of the City Code; and

NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF SOUTH PASADENA THAT:

SECTION 1. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and are incorporated herein as a specific part of this Resolution.

SECTION 2. Findings.

Pursuant to Section 130-48(A) of the City Code, the City Commission hereby finds that:

1. Granting the Special Exception will not adversely affect the public interest.
2. The requested use is reasonably compatible with surrounding uses.
3. The land and building area is adequate for the operation of the use.
4. Approval of the Special Exception will not result in reduced land values or detract from surrounding areas.

SECTION 3. Approvals.

The City Commission hereby approves Special Exception Application No. PNZ-0526-005, pursuant to Sections 130-17(C)(3) and 130-48 of the City Code, authorizing the replacement of approximately ninety (90) linear feet of existing seawall construction of the replacement seawall utilizing vinyl sheet piling extending up to twelve (12) inches waterward of the existing seawall face, and an increase in the finished top-of-seawall elevation from approximately 4.9 feet NAVD88 to 5.9 feet NAVD88,, an increase of approximately twelve (12) inches, at the property located at 7140 South Shore Drive S, South Pasadena, Florida, subject to the following conditions pursuant to Section 130-48(B) of the City Code:

1. The proposed replacement seawall, including the approved alignment, shall be constructed substantially in accordance with the plans and supporting documents submitted with Special Exception Application PNZ-0526-005, except as may be modified by the City Commission.
2. The approved finished top-of-seawall elevation shall not exceed 5.9 feet NAVD88, referenced to the North American Vertical Datum of 1988 (NAVD88).
3. The replacement seawall utilizing vinyl sheet piling shall not extend more than twelve (12) inches waterward of the

existing seawall face. Any extension beyond twelve (12) inches shall require additional City review and approval, as applicable, in addition to any required authorization from other regulatory agencies.

4. The applicant and property owner shall obtain all applicable federal, state, county, and local permits and approvals prior to commencement of construction.

5. Any proposed change to the approved finished top-of-seawall elevation, approved seawall alignment, or other material revision to the approved Special Exception shall require review and approval by the City in accordance with the City Code.

SECTION 4. Severability.

If any section, part of section, paragraph, clause, phrase or word of this Resolution is declared invalid, the remaining provisions of this Resolution shall not be affected.

SECTION 5. Effective Date.

This Resolution shall become effective upon the date of its passage and adoption herein.

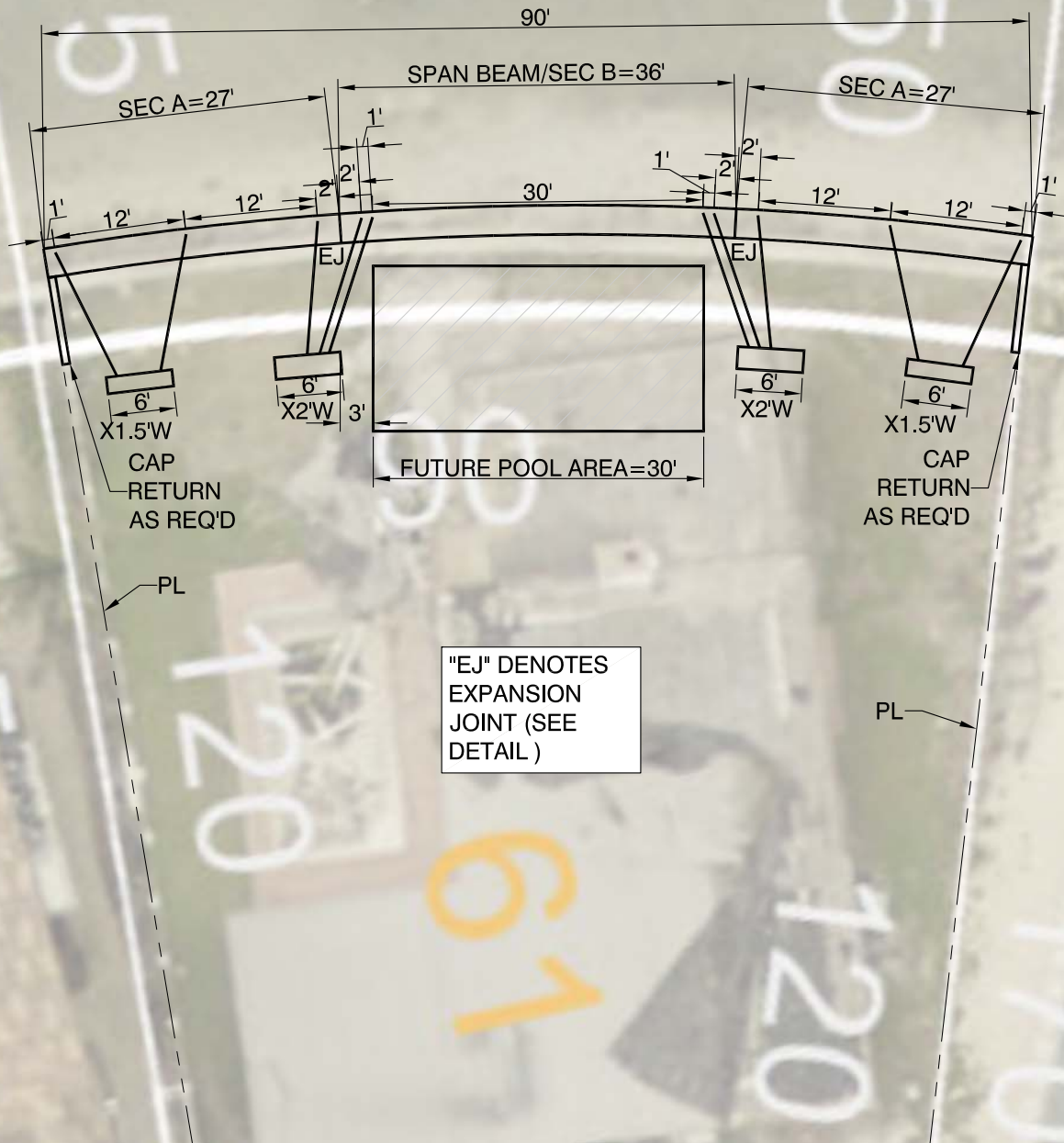
Key details regarding the project impact and community considerations include:

- Building Design: The engineering design increases the wall height by 12 inches, and the new vinyl sheets will be driven within 12 inches of the current wall. This design minimizes environmental impacts while maximizing protection. There will be no effect on the line of sight for neighboring properties.
- Drainage & Environment: The design ensures that drainage patterns will not adversely affect neighboring properties. Additionally, the impervious ratio will remain unchanged as we are building waterward.
- Property Impact: Due to the minimal height increase, neighboring views will not be compromised, and there will be no adverse impacts to adjacent lots. Setbacks are not a factor in the evaluation of this project.
- Community Mindfulness: To minimize disruption to neighbors, construction hours will be limited to 8:00 a.m. through 4:00 p.m., Monday through Friday.
- Traffic & Logistics: All materials and equipment will be kept within the project yard, and all parking will be restricted to the project driveway to reduce traffic impacts to the community.

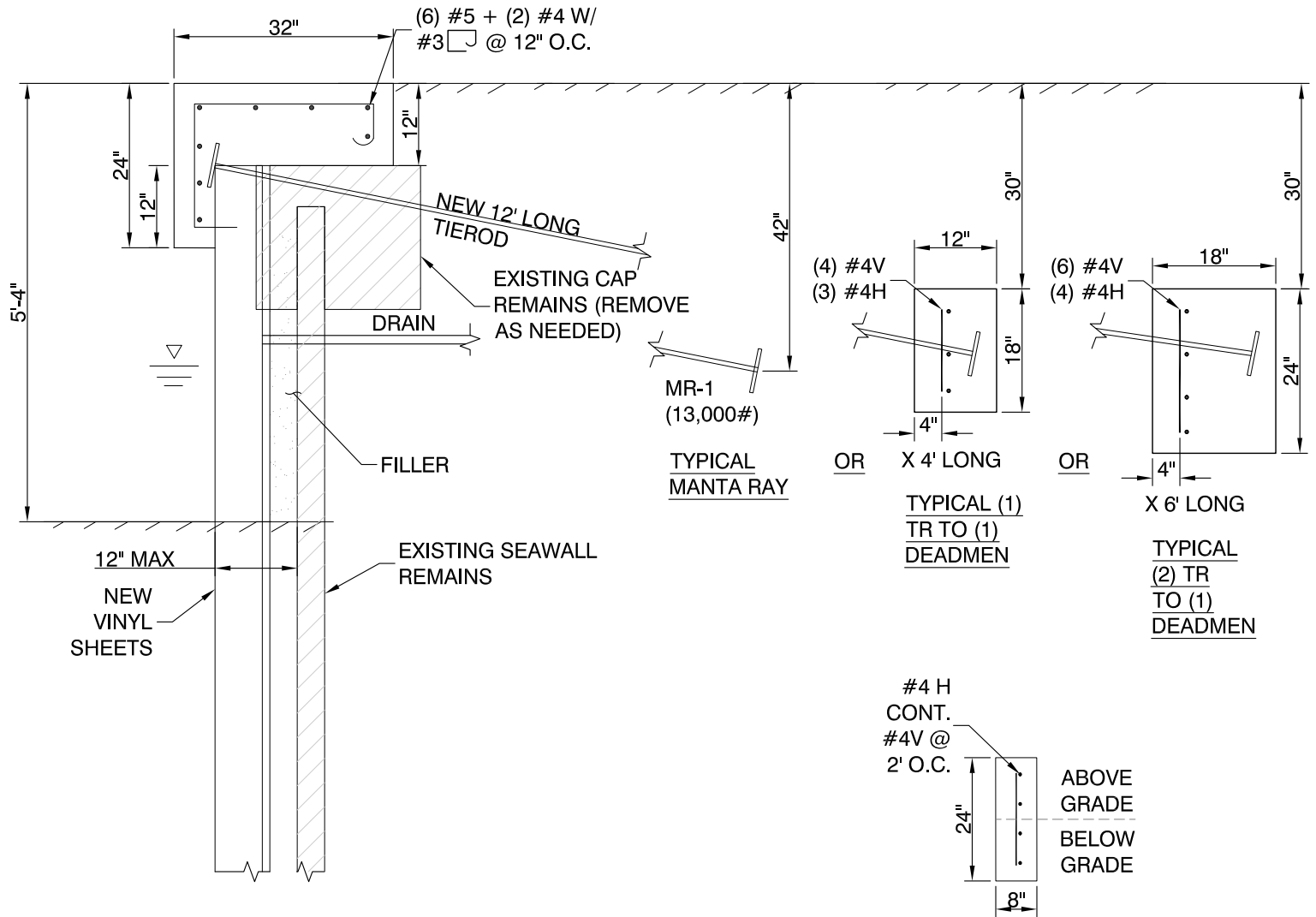

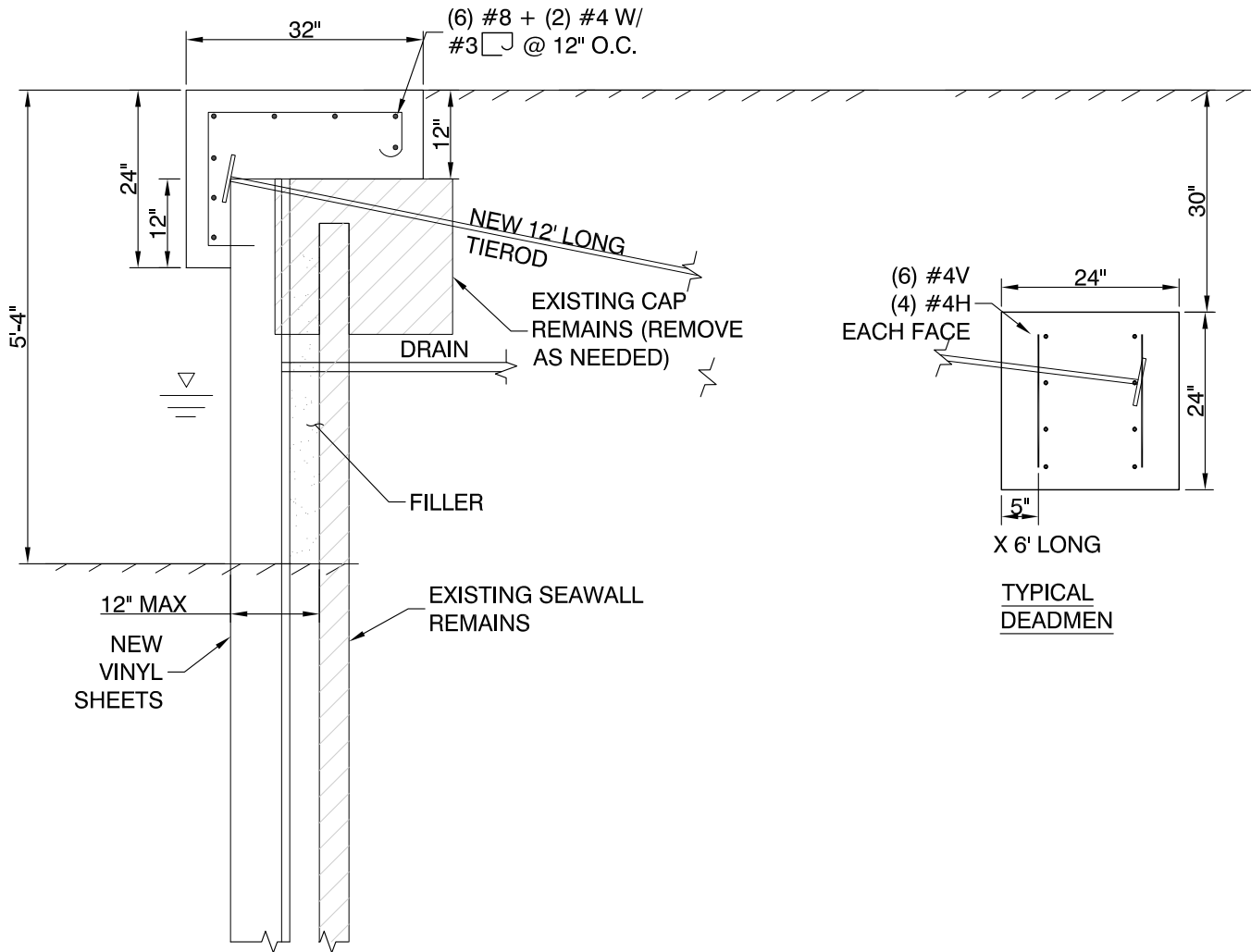

ORDINANCE NO. 2026-01

AN ORDINANCE OF THE CITY OF SOUTH PASADENA, FLORIDA, AMENDING APPENDIX CHAPTER A198 FEES OF THE CODE OF ORDINANCES RELATING TO RATES AND CHARGES FOR SEWAGE USAGE; TO INCREASE THE BASE MINIMUM MONTHLY SEWER RATES AND SEWER FLOW CHARGE RATE BY 5.0%; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Commission desires to gradually adjust rates to cover the cumulative effects of the increases in sewer processing rates and any new annual processing charges; and

WHEREAS, the City of St. Petersburg has proposed increasing processing fees by 4.89% for Fiscal Year 2027 from \$7,179 per million gallons (PMG) to \$7,530 PMG; and

WHEREAS, the City of South Pasadena's projected sewer processing volume for Fiscal Year 2027 is 152 million gallons or higher; and

WHEREAS, the St. Petersburg processing charges for 2027 will cost an estimated \$1,462,500 based on expected processing volumes of 152 million gallons; and

WHEREAS, no change in Sewer Fees for Fiscal Year 2026 would result in an estimated \$53,401 cash flow deficit; and

WHEREAS, the City Commission desires to have the Sewer Enterprise Fund at or near a breakeven cash flow; and

WHEREAS, The City Commission desires to recover the additional \$53,401 in additional costs, and

WHEREAS, a recommended 5.0% increase in variable and fixed charges is expected to generate \$1,950,000 in Sewer Fee Revenue resulting in no deficit; and

WHEREAS, Pinellas County Utilities has adopted wholesale reclaimed water rate increases from Fiscal Year 2025 through Fiscal Year 2027; and

WHEREAS, there is a 15.00% approved increase from \$760.43 to \$874.50 per million gallons (PMG) for the fiscal year ending in September 2027; and

WHEREAS, the projected increase in reclaimed water costs for Fiscal Year 2027 is approximately \$20,244 with a total cost of \$155,000 based on expected processing volumes of 177 million gallons; and

WHEREAS, a recommended 15.00% increase in Reclaimed Water Fees is expected to generate \$345,000 or an additional \$23,800 annually in Reclaimed Water Revenue; and

MAJOR FUNCTION

Assists the Mayor, Commissioners, and City Attorney in the areas of strategic planning, project scheduling, budgeting, City activities, and drafting of legislation and policies.

Attends City meetings and events as appropriate including but not limited to meetings of the City Commission, boards and committees, project coordination, and recreational/educational events.

Represents the City to outside agencies and cultivates relationships to promote the interests and welfare of the City, including travel and public speaking as needed.

Assists the Commission and department heads in overseeing all full-time, part-time, and contracted employees of the City with the exception of the City Attorney.

Serves as the Chairperson of the department head team. Assigns and coordinates projects and responsibilities to appropriate department heads and reports such assignments to the Commission.

Acts as Personnel Coordinator. Oversees Citywide staffing and assists department heads with human resources functions including hiring, firing, promotions, and the administration of discipline, coordinating with the City Attorney as needed.

Conducts performance evaluations for department heads on behalf of respective Commissioners.

Conducts presentations to the City Commission on various projects and initiatives as needed.

Oversees the Administration Department and the general administrative functions of the City.

Develops, implements, and monitors Citywide activities and operations to promote uniform application of policies.

Administers rules and regulations governing City operations. Interprets, analyzes, and implements procedures and programs to applicable City staff.

Confers with residents, businesses, and outside agencies having related to the interests of the City.

Guides department heads in developing operating policies and procedures for City functions and personnel, including recommending appropriate service and staffing levels while allocating resources to ensure consistency and facilitate collaboration between departments.

Reports for duty in the event of a natural disaster.

Performs job related work as required.

QUALIFICATIONS

Knowledge, Abilities and Skills: Thorough knowledge of public sector operations and management practices. Understanding of regulatory environment governing municipalities in Florida. Ability to work with elected officials, City staff, and outside stakeholders in a professional and effective manner. Strong communication, analytical, and problem-solving skills. Knowledge and experience related to hurricane response and FEMA processes preferred.

Master's degree preferred. Demonstrated administrative public sector experience, including significant experience in a supervisory capacity. SHRM certification preferred.

MAJOR FUNCTION

This is administrative work of a highly responsible nature assisting the City Commission and Department Heads with the legislative and administrative functions of the City. Duties include organizing and providing administrative support to applicable meetings, recording City actions, and maintaining the records of the City. Position administers City elections and serves as the Custodian of Public Records for the City.

Serves as a Notary Public for internal processes and members of public in accordance with City policies.

Performs all of the duties of City Clerk as specified in the City Charter and the laws of the State of Florida.

WHEREAS, the Sheriff of Pinellas County has historically
provided satisfactory police service to the City of South Pasadena;
and

WHEREAS, the proposed contract provides that the City will, by
appropriate Resolution, appoint the Sheriff as the Police
Department of the City for the term of the contract.

NOW, THEREFORE, BY RESOLUTION HEREOF, the City Commission of
the City of South Pasadena hereby declares that the Sheriff of
Pinellas County is appointed as the Police Department of the City
and shall perform the duties and functions and shall have the power
and authority thereof for the fiscal year beginning October 1, 2026
and ending September 30, 2027. The Mayor is hereby directed to
execute the contract which is attached hereto marked Exhibit "A".

CONTRACT FOR LAW ENFORCEMENT SERVICES

THIS AGREEMENT is made and entered into by and between the CITY OF SOUTH PASADENA, FLORIDA (hereinafter "CITY") and BOB GUALTIERI, as Sheriff, Pinellas County, Florida (hereinafter "SHERIFF").

WITNESSETH:

WHEREAS, the CITY is a municipality within the boundaries of Pinellas County, Florida; and

WHEREAS, the CITY has requested that the SHERIFF furnish law enforcement protection to its inhabitants and citizens; and

WHEREAS, the CITY desires that the SHERIFF furnish law enforcement protection on a full-time basis and do and perform any and all necessary and appropriate functions, actions, and responsibilities of a law enforcement force for the CITY; and

WHEREAS, the City Commission of the CITY has determined that the most efficient way to fulfill its responsibility of providing law enforcement protection for the year beginning October 1, 2026, and ending September 30, 2027, is by contracting with the Pinellas County Sheriff; and

WHEREAS, the SHERIFF has indicated his desire and willingness to accept and fulfill the responsibilities herein before mentioned;

NOW, THEREFORE, in consideration of the mutual promises contained herein and given by each party to the other, the parties hereto do covenant and agree as follows:

1. By appropriate Resolution, the City Council of the CITY shall declare that the SHERIFF shall perform the duties and functions and shall have the power and authority of a Police Department of the CITY during the contract period.

2. The SHERIFF shall, to the extent feasible, coordinate law enforcement functions with the CITY's Department of Public Safety. A representative from the Pinellas County Sheriff's Office will attend regular City Council meetings.

3. The SHERIFF hereby agrees to provide all necessary and appropriate law enforcement services in and for the CITY by providing two (2) deputies with patrol automobiles for twenty-four (24) consecutive hours each day to serve as law enforcement officers of the CITY. Said deputies shall be provided to the CITY on the basis of two (2) deputies per shift twenty-four (24) hours per day, seven (7) days per week.

The deputies assigned to the CITY are authorized to patrol and respond to calls for service in the unincorporated area adjacent to the CITY. In exchange, the CITY will receive a credit as set out in the attached work sheet to the yearly cost of service.

The SHERIFF shall make all services of the Sheriff's Office available to the CITY which includes, but is not limited to, routine marine patrol of City waters, K-9, helicopter patrol and crime watch assistance. Through directed patrol efforts, the SHERIFF will conduct periodic speed monitoring of South Pasadena's vehicle traffic as needed. Any specific problems with marine infractions that are reported to the Pinellas County Sheriff's Office will be handled as a law enforcement complaint.

4. In addition to the services described above in Paragraph 3, the SHERIFF will also provide (1) part-time Community Policing Deputy/Code Enforcement, who shall be provided on an as-needed basis. The specific hours of work of this community policing deputy shall be determined by his or her supervisor after consultation with the CITY. The community policing deputy will investigate and take enforcement actions for violations of the CITY'S Code of Ordinances, will track and prepare statistical reports for the CITY concerning the numbers and

types of violations issued on a monthly basis, and interact with both citizens and businesses to address and resolve code violation related issues. The community policing deputy will in conjunction with the CITY'S attorney, prepare and present code violations cases before the CITY'S Magistrate as necessary, and in conjunction with the CITY'S administrative/clerical staff, prepare citations, send notices of violations and appeal hearings and perform other related administrative tasks. The CITY agrees it will provide at its expense the necessary code enforcement training, the assistance of the CITY'S administrative and clerical staff for performing research, preparing and sending out notices and correspondence, and other like administrative and clerical tasks, and the appropriate office space and equipment needed for the performance of the community policing deputy's administrative duties.

5. The SHERIFF shall discharge his responsibility under this Agreement by the enforcement of all state laws, county ordinances applicable within the CITY, and ordinances of the CITY. The SHERIFF shall bring appropriate charges for violations of all laws and ordinances.

6. It is understood and agreed that all fines and forfeitures rendered in any court as a result of charges made by the SHERIFF shall be distributed according to general law and the rules of the court.

7. The SHERIFF shall maintain Uniform Crime Reporting records regarding crimes committed within the CITY. These records shall include the number and type of crimes committed, the number of arrests made for each type of crime, and any other information as required by law. A computer printout reflecting this information shall be furnished to the CITY each month.

8. The SHERIFF shall provide each deputy who provides services under this Agreement with a patrol automobile and all other necessary or appropriate equipment. Deputies providing services under this Agreement shall operate out of the Sheriff's Administration Building or North District Station. The cost of operating and maintaining these facilities and the cost of purchasing, maintaining and repairing equipment used under this Agreement shall be borne by the SHERIFF.

9. The SHERIFF shall be responsible for the appointment, training, assignment, discipline and dismissal of all his law enforcement personnel performing services under this Agreement. Lawsuits and claims that may be filed from time to time hereunder shall be handled by the SHERIFF in accordance with normal procedures. The SHERIFF shall defend such lawsuits and claims and pay judgments or settlements in accordance with law. The SHERIFF is in compliance with Florida Statute §448.095 which references the use of E-Verify.

10. The parties to this Agreement are represented by the following attorneys:

11. This Agreement shall take effect on October 1, 2026, and continue in effect thereafter through September 30, 2027, unless hereafter extended upon such terms and conditions as the parties hereto may later agree, or terminated by any party upon ninety (90) days' notice in writing to the other parties.

The parties agree that where the Agreement is not terminated as provided for herein,

the terms of this Agreement shall automatically continue for 120 days beyond September 30, 2027, in the event a replacement contract has not yet been completely executed. The CITY shall continue to pay to the SHERIFF on a monthly basis the amount due per this Agreement, until such time as a replacement contract has been approved. The parties further agree that an increase, if any, in the cost of service, shall be retroactively applied for services rendered from October 1, 2027, to the approval and execution of the replacement contract, and shall be paid by the CITY to the SHERIFF immediately for the services already provided.

12. With the exception of the service provided by the Community Policing Deputy/Code Enforcement, the CITY shall pay to the SHERIFF as payment in full for all of the services herein agreed to be performed by the SHERIFF, the sum of ONE MILLION TWO HUNDRED TWENTY THOUSAND FIFTY-TWO DOLLARS AND NO CENTS (\$1,220,052.00). Payment shall be made in twelve monthly installments of ONE HUNDRED ONE THOUSAND SIX HUNDRED SEVENTY-ONE DOLLARS AND NO CENTS (\$101,671.00). Payment shall be made on the first day of each month beginning on the 1st day of October 2026. (See Attachment 1.) The SHERIFF shall invoice the CITY monthly for the services of the Community Policing Deputy/Code Enforcement based upon the actual number of hours worked at a rate of SIXTY-SEVEN DOLLARS AND FIFTY-FIVE CENTS (\$67.55) per hour, which shall be due upon receipt. The annual sum referenced above and the monthly amount for code enforcement services represent one hundred percent (100%) of the total cost of the contract with the CITY OF SOUTH PASADENA. (See Attachment 1.)

13. In no event shall this Agreement confer upon any third person, corporation or entity other than the parties hereto any right or cause of action or damages claimed against

either of the parties to this Agreement arising from the performance of the obligation and responsibilities of the parties herein or for any other reason.

14. This Agreement reflects the full and complete understanding of the parties to it and may be modified or amended only by a document in writing executed by the parties hereto and executed with the same formality of this Agreement.

THIS INTERLOCAL AGREEMENT FOR PLANNING AND MAPPING SERVICES AND/OR SPECIAL PROJECT WORK, hereinafter referred to as “Agreement”, is made and entered into this _____ day of _____, 20____, by and between FORWARD PINELLAS, in its role as the Pinellas Planning Council and the Pinellas County Metropolitan Planning Organization (hereinafter referred to as “Forward Pinellas,”) and the CITY OF SOUTH PASADENA (hereinafter referred to as the “Local Government”), individually known as a “Party” and collectively known as the “Parties.”

WHEREAS, Forward Pinellas and the Local Government entered into an interlocal agreement to provide planning and mapping services on October 1, 2018 and subsequently amended the agreement to extend the term for an additional four (4) years; and

WHEREAS, the current interlocal agreement between the Parties expires on September 30, 2026; and

WHEREAS, Forward Pinellas desires to continue to provide planning and mapping services and/or special project work to the Local Government on an as needed and as available basis; and

WHEREAS, the Local Government desires to have the option to engage Forward Pinellas staff to provide planning and mapping services and/or special project work; and

WHEREAS, related planning and mapping services and/or special project work can be provided in support of the Countywide Plan as may be requested by the Local Government; and

WHEREAS, Forward Pinellas can provide the Local Government additional planning and mapping services and/or special project work through its agreement with the Pinellas County Enterprise Geographic Information Systems (GIS); and

WHEREAS, due to the expiration date of the previous agreement and desire to clarify the Parties and scope of work, it is necessary to replace the previous agreement; and

WHEREAS, Forward Pinellas and the Local Government desire to cooperate in the provision of said planning and mapping services and/or special project work to maximize efficiency and minimize cost and ensure the maximum degree of coordination and accuracy.

NOW THEREFORE, in consideration of the covenants made by each Party to the other and of the advantages to be realized by this Agreement, Forward Pinellas and the Local Government agree as follows:

Section 1. Authority

This Agreement is entered into pursuant to the general authority of Section 163.01, Florida Statutes, relating to interlocal agreements and the specific authority of Sections 6(3) and 6(6) of Chapter 2012-245, Laws of Florida, as amended.

Section 2. Term

The term of this Agreement shall be from October 1, 2026 through September 30, 2030; which term may be renewed by mutual written agreement, signed by both Parties, for one additional four-year period through September 30, 2034, unless terminated as provided for elsewhere in this Agreement.

Section 3. Scope of Services

- A. The Scope of Services is provided in Exhibit A attached hereto and hereby made a part of this Agreement.
- B. Any assistance provided or project undertaken as provided for in the Scope of Services may, upon mutual agreement of Forward Pinellas staff and the Local Government, be more specifically detailed as to methodology, schedule, work product, and cost in a memorandum of understanding executed consistent with and pursuant to this Agreement.
- C. Responsibility for the correctness of information provided to Forward Pinellas for use in rendering planning and mapping services and/or special project work under this Agreement, and any liability related thereto, lies with the Local Government.
- D. All requests for planning and mapping services and/or special project work to be provided under this Agreement shall be in writing by an authorized representative of the Local Government.
- E. Forward Pinellas reserves the right to accept or reject and to schedule all requests for planning and mapping services and/or special project work based on the ability of the Forward Pinellas staff to produce the requested planning and mapping and/or special project product(s) pursuant to the required timetable there for.

Section 4. Charges

- A. Payment and charges for services rendered under this Agreement shall be as provided for in Exhibit B, Payment and Rate Charge Schedule, attached hereto and hereby made a part of this Agreement.
- B. Ongoing planning and mapping services and/or special project work will be charged as a lump sum or on a time and material basis as mutually agreed by the Local Government and Forward Pinellas staff in accordance with the terms of this Agreement.
- C. The Local Government agrees to make payment to Forward Pinellas for all properly invoiced requisitions as set forth in Exhibit B, within forty-five days of submission.
- D. The fee schedule may be revised by mutual written consent, signed by both Parties, and included as an addendum to this Agreement.

Section 5. Use of Product

- A. The Local Government shall have the exclusive control of the public distribution of all information produced by Forward Pinellas prior to its adoption. Forward Pinellas shall not voluntarily distribute information prior to its adoption by the Local Government without prior approval.
- B. Forward Pinellas has the right to use any information produced under this Agreement for similar purposes upon removing all reference to the Local Government.
- C. The Local Government shall have the exclusive control of the public distribution of mapped information provided under this Agreement.
- D. Nothing contained in this Agreement shall prohibit either Party hereto from complying with a public records request submitted pursuant to Chapter 119, Florida Statutes.
- E. Forward Pinellas shall retain all rights to the original data as compiled for and used in the production of the Countywide Plan Map from which the Local Government map is produced.

Section 6. Accounting and Records

- A. Forward Pinellas shall establish an accounting process to identify the costs and revenues associated with the Agreement. All accounting documentation shall be available for inspection, upon request, by the Local Government at any time during the period of this Agreement and for a minimum of three years after payment is made, or the requisite statutory record retention period, whichever is longer.

- B. All charged costs shall be supported by the properly executed payroll, time records, invoices, contracts or vouchers, evidencing in proper detail the nature and propriety of the charges.

Section 7. Notice

Notice by either Party to the other pursuant to this Agreement shall be given in writing and hand delivered or mailed as follows:

Section 8. Construction

This Agreement shall be construed as an expression of inter-agency cooperation enabling each Party to make the most efficient use of its powers in furtherance of the respective and common objectives. However, this Agreement shall not be construed as delegating or authorizing the delegation of the constitutional or statutory duties of either Party to the other.

Section 9. Termination

This Agreement may be terminated by either Party at any time by giving the other Party not less than thirty days' notice of such termination. In the event this termination provision is exercised by either Party, the Local Government shall remain liable to Forward Pinellas for charges incurred up to such termination.

Section 10. Filing; Effective Date

As required by Section 163.01(11), Florida Statutes, this Agreement shall be filed with the Clerk of the Circuit Court of Pinellas County, Florida, after execution by the Parties, and shall take effect upon such filing.

Section 11. Successor Agency

In the event Forward Pinellas is reconstituted as a new agency, merged with another agency, or its legal status is otherwise altered, this Agreement will be automatically assigned to any new agency that assumes the planning and mapping services and/or special project work currently performed by Forward Pinellas. This assignment shall be effective without the need for any further written agreement between the Parties. The Local Government shall retain the right to terminate this agreement in accordance with Section 9.

EXHIBIT A

SCOPE OF SERVICES

I. Ongoing Planning Services

- A. Forward Pinellas agrees to consider requests by the Local Government for ongoing planning services and to provide such services as Forward Pinellas staff time and schedule permit.
- B. Ongoing planning services may include, but are not limited to, review and interpretation of the comprehensive plan and land development regulations, comprehensive plan and land development regulation amendments, assistance with applications for development approval, traffic analysis, transportation planning, and data collection, as determined to be consistent with the mission and role of Forward Pinellas.

II. Mapping Services

- A. Forward Pinellas agrees to consider requests by the Local Government for mapping services and to provide such services as Forward Pinellas staff time and schedule permit.
- B. Mapping services may include, but are not limited to, provision of custom or standard printed or electronic map products, as determined to be consistent with the mission and role of Forward Pinellas.
- C. Forward Pinellas staff will serve as a liaison to the Pinellas County Enterprise Geographic Information Systems (EGIS) if such additional mapping services are required.

III. Special Planning Projects

- A. Forward Pinellas agrees to consider requests by the Local Government for assistance with special planning projects and to provide such assistance as Forward Pinellas staff time and schedule permit.
- B. Special planning projects may include, but are not limited to, plan or land development regulation assessments, neighborhood or special area plan development, special transportation and/or planning studies and such other special projects as may be related to or in furtherance of the comprehensive and/or transportation planning process, including customary ancillary and support activities needed to conduct such projects, as determined to be consistent with the mission and role of Forward Pinellas.

EXHIBIT B

PAYMENT AND RATE CHARGE SCHEDULE

I. Ongoing Planning and Mapping Services

Forward Pinellas shall requisition by invoice for ongoing planning and mapping services on a time and materials basis as follows:
