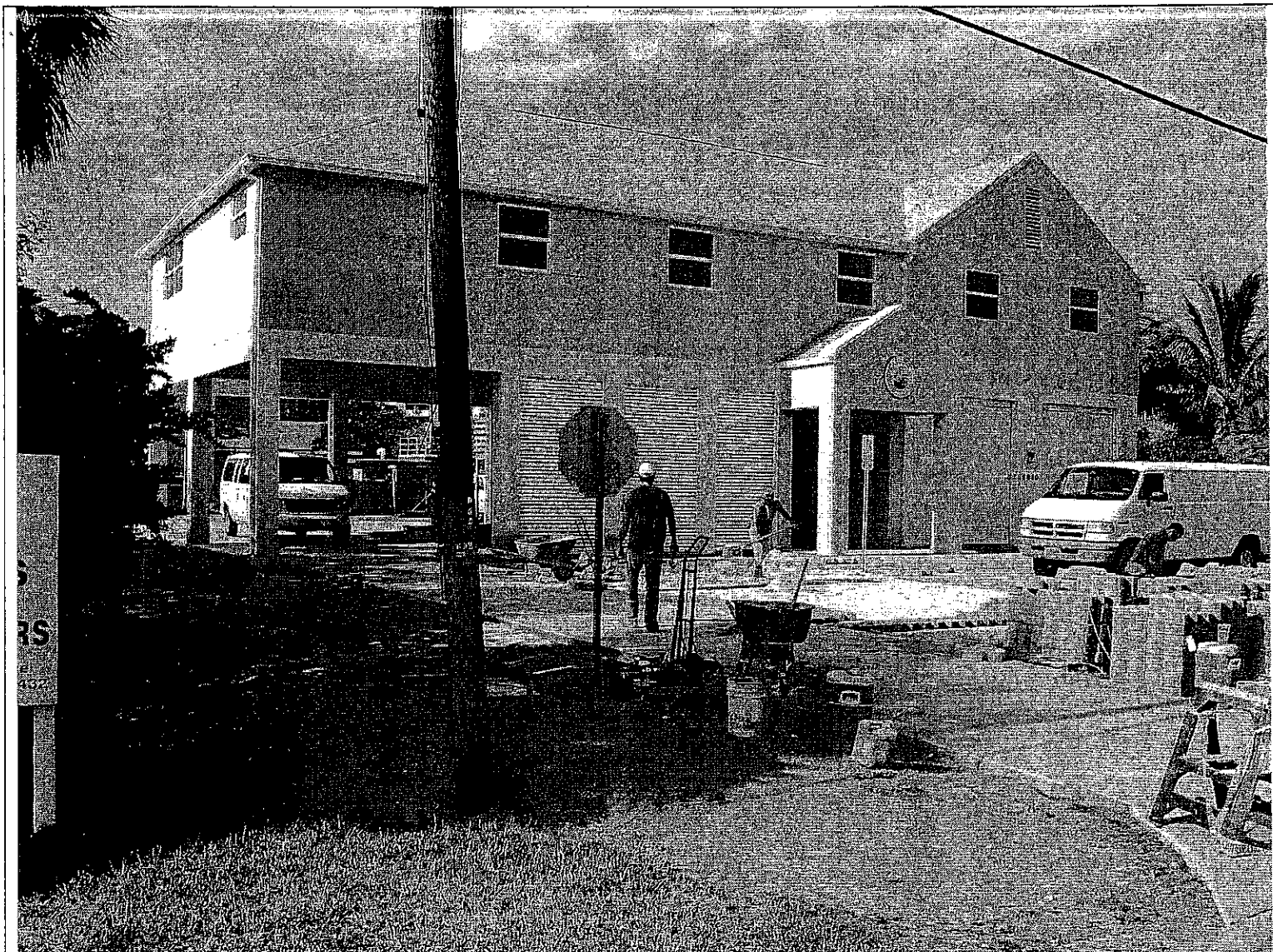

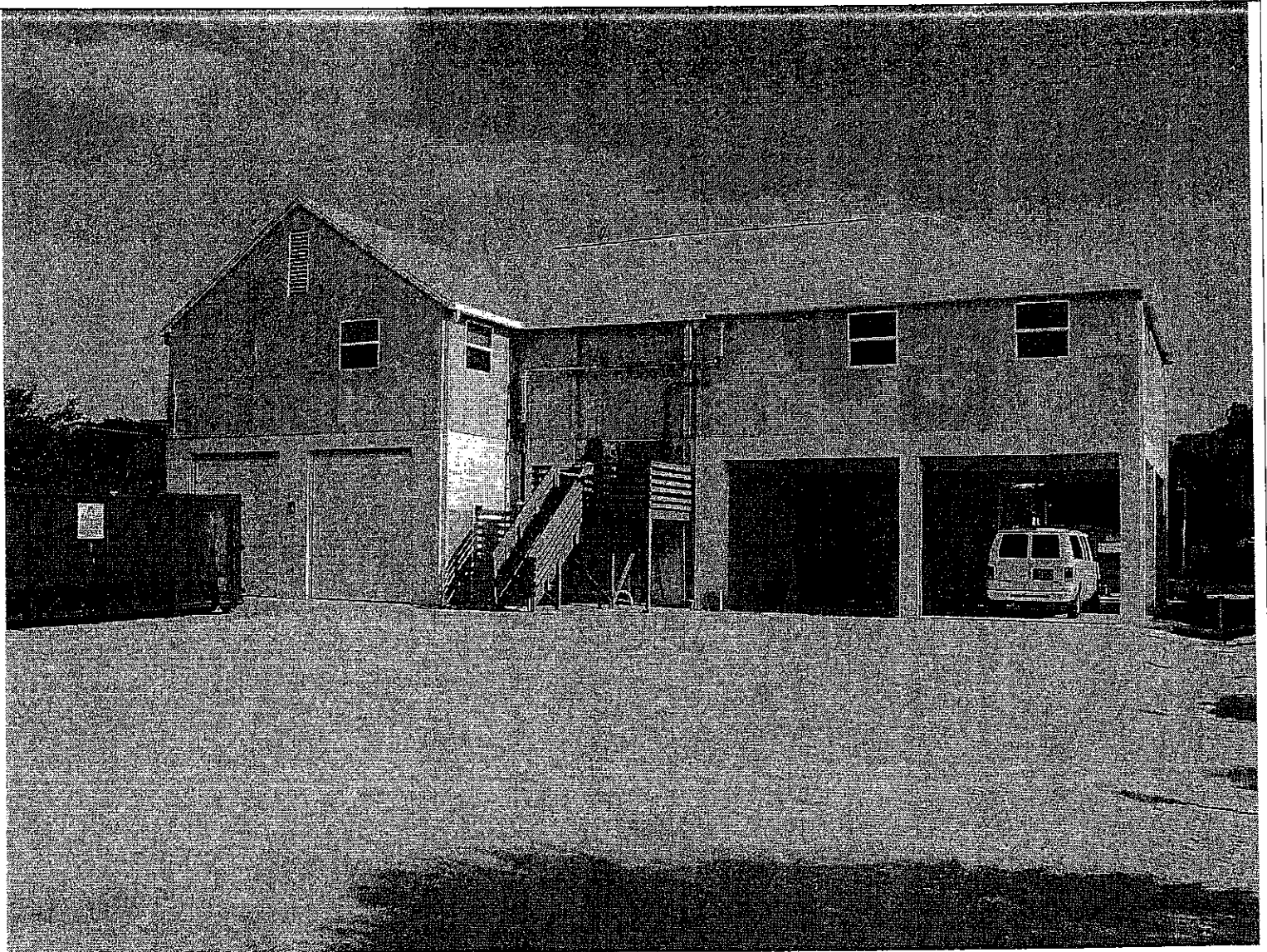

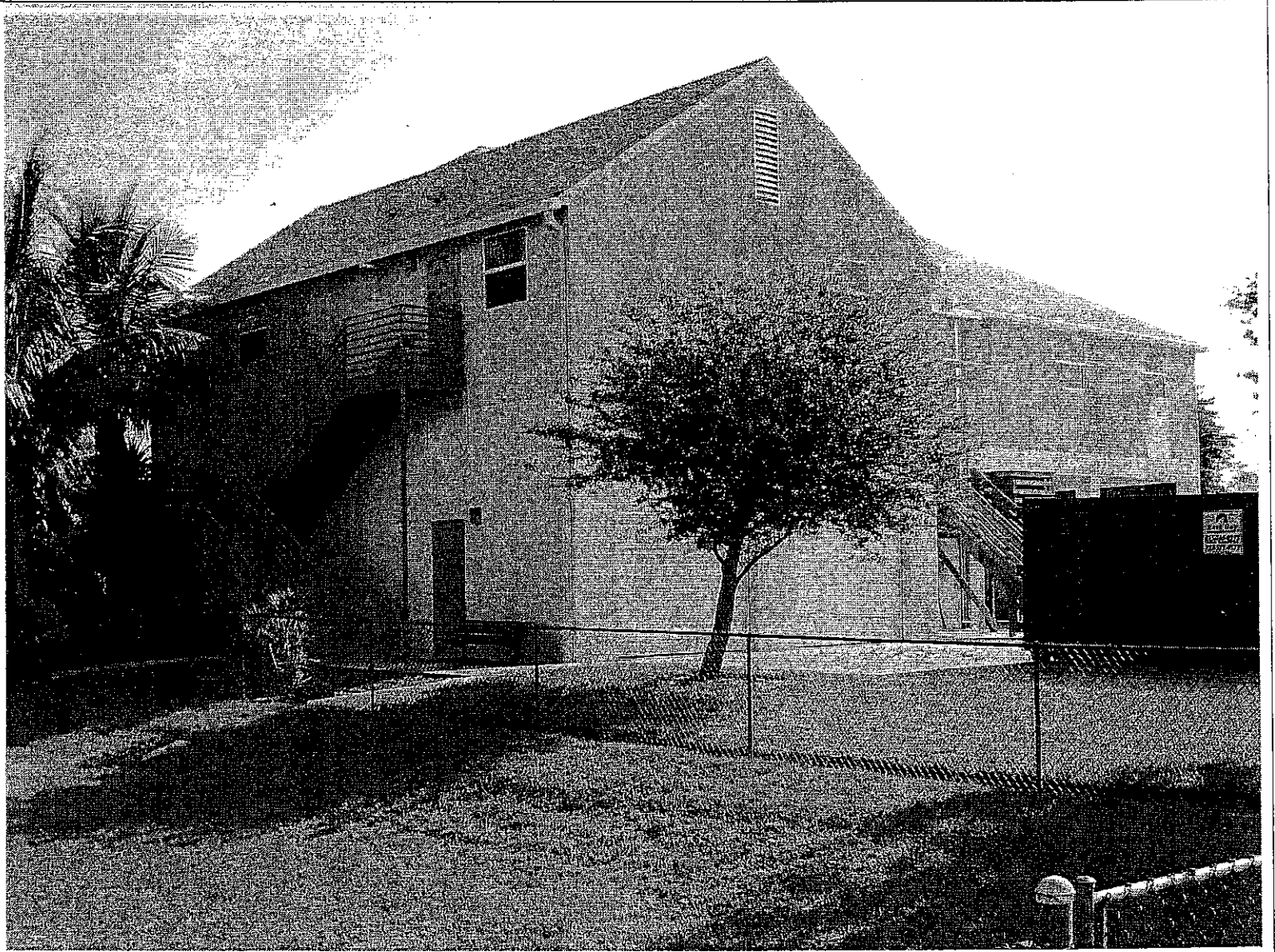


FRONT SIDE LEFT VIEW 10/09/07
