REPORTS

Commissioner Neidinger spoke regarding Finance Department activities including the budget process for FY2026, audit processes, ad valorem tax collections, and City financial reports.

Commissioner McAlees reported on Community Improvement Department activities including software upgrades, the five-year Community Rating System (CRS) visit, and permitting activity. He noted that a new office assistant has been hired.

Commissioner Thompson reported on Public Safety activities including hurricane season predictions and the importance of preparing for hurricane evacuation orders.

Vice Mayor Reid reported on Public Works Department activities including the Bay View Park pavilion project, lift station and manhole repairs, reclaimed water cross-connection inspections, landscaping, and repairs to City facilities.
