a Special Commission Meeting duly assembled on Tuesday, March 25,
2025 resolves as follows:

WHEREAS, Resolution No. 2024-06 passed on October 17, 2024
called for a General Election to be held on March 11, 2025 for the

WHEREAS, the Pinellas County Canvassing Board, serving as the
City's Canvassing Board, canvassed all votes cast at the March 11,
2025 election in accordance with the laws of the State of Florida
and the City of South Pasadena and has certified the following
